17. I, or we, do hereby agree and obligate the recipient of any retail beer permit or retail liquor permit issued pursuant to this application, under full penalty of the law, to the following terms and conditions:
(1) That alcoholic beverages containing more than 5% alcohol by weight and as described in Section 67-1-5(a) of the Mississippi Code of 1972, Annotated, as Amended, will not be sold, kept, or stored, in or on the premises for purpose of sale unless a license has been secured from the State of Mississippi to sell such alcoholic beverages.

(2) That alcoholic beverages containing more than 5% alcohol by weight and as described in Section 67-1-5(a) of the Mississippi Code of 1972, Annotated, as 3 Amended, will not be possessed by any person, or sold, kept, or stored in or on the premises in areas that do not allow the sale of such beverages.

(3) That beer, wine, or alcoholic beverages containing more than 5% alcohol by weight and as described in Section 67-1-5(a) of the Mississippi Code of 1972, Annotated, as Amended, will not be sold or given to be consumed in or upon any licensed premises between the hours of midnight and seven o'clock the following morning or during any time the licensed premises may be required to be closed by municipal ordinance except, however, in areas where the sale of alcoholic beverages is legal under the provisions of the local Alcoholic Beverage Control Law and the hours for selling such alcoholic beverages have been extended beyond midnight for on-premises under Section 67-1-37, the hours for selling beer or light wines are likewise extended in areas where the sale of beer or light wines is legal.

(4) That beer, wine, or alcoholic beverage will not be sold, furnished or given to any person under the age of 21 years.

(5) That loud, boisterous or disorderly conduct, or loud musical instruments will not be permitted or conducted on the premises, and nothing will be done to disturb the peace and quietude of the community wherein such business is located.

(6) That any of the laws of the State of Mississippi will not be violated by the applicant, or that the applicant will not knowingly allow any person to violate the laws of the State of Mississippi while in or on the premises.

(7) That all invoices covering purchases of beer and alcoholic beverages for sale upon the premises will be carefully preserved for inspection, and that all rules and regulations promulgated by the Commissioner under the provisions of the law will be complied with in the operation of the business for which the permit is procured.

(8) I have read and understand Ordinance No. ____ and the amendments thereto of the City of Quitman, Mississippi. All of the foregoing representations apply individually and collectively to all officers, directors, and the person or persons managing the licensed premises of any corporation and to any such stockholder of such corporation owning more than 5% of the stock of such corporation making application for this permit.

AFFIDAVIT FOR RESTAURANT APPLICATION ONLY

I, the undersigned, _____, an applicant for a Privilege License to sell alcoholic beverages under the provisions of Ordinance ____, and the amendments hereto, enacted by the Mayor and Board of Aldermen of the City of Quitman, Mississippi, on the ____th day of _____, 2017, hereby certify as follows:

1. That I have been furnished with a copy of the afore-said Ordinance; that I have read and thoroughly understand the same; and that, if I am granted the said Privilege License, I agree to comply fully with each and all the requirements and restrictions therein contained.

2. That, if granted the said license, my business will be located at _____, and that said location is not within the prohibited limits from any church, school, hospital, funeral home, nursery, nursing home, day care center, kindergarten, or publicly-owned recreation center.

3. That, if granted the said license, I will maintain a restaurant, as defined by Section 4 of said Ordinance at the above-mentioned location. I further understand that, in order to maintain such a restaurant, I must:

(a) Maintain a business which is regularly and in a bona fide manner used and kept open for the service of meals to guests for compensation.

(b) Maintain adequate seating facilities for guests and have suitable kitchen facilities connected therewith for cooking an assortment of foods and meats commonly ordered at various hours of the day. Further, I understand that the service of foods such as sandwiches and salads only will not be sufficient compliance with the foregoing.

(c) Not sell beer or alcoholic beverages pursuant to this license unless the person or persons ordering the same be seated.

(d) Maintain adequate sanitary facilities and restroom.

4. That, if granted the said license, I will not erect or maintain any sign advertising the sale of beer pursuant to Section 5 and 7.

5. That, if granted the said license, I will not permit the sale of beer in my establishment between the hours of 10:30 p. m. and 7:00 a. m. or on Sunday.

6. That, if granted the said license, I will not allow beer or alcoholic beverages to be sold to or served to minors under 21 years of age.

7. That all the statements contained in my application are true and correct.

8. That, if granted the said license, I will, whenever called on so to do, furnish the issuing authority or agents of the City of Quitman, Mississippi, with such records, documents, or other evidence as may be necessary in order to prove compliance with the said Ordinance. I understand that should it be proven

that any statement or certification contained herein is untrue or incorrect or should I violate any provision of the aforesaid Ordinance, my permit, if granted, may be revoked. WITNESS my signature on this the ____ day of _____ 20____
