

## Tournament Rules

1. *Participants must properly complete and sign the Official Application form and submit the proper entrance fee before 5:30 a.m. on the date of the tournament.*
2. *Must have valid MS fishing license.*
3. *Only artificial baits may be used. Only casting, spinning or spin cast rod and reels may be used. No trolling allowed.*
4. *Safe motoring conduct must be observed at all times to satisfy the Archusa Water Park Regulations. Life Preservers must be worn whenever the gas motor is running.*
5. *Fishing is permitted any place at Archusa Water Park, except within 50 yards of any contestant's boat that is first anchored in that location. All contestants must leave and return to the official area by boat except in cases of dire emergency or severe weather.*
6. *The Archusa Water Park boat ramp will be the official site for launching. The point at the bath house will be the official site for weigh-in.*
7. *Starting will be an "ease out". Boats will be released in order of registration.*
8. *Tournament hours will be from safe light to 2:00 p.m., weather permitting.*
9. *Contestants who are not at the point at posted time will be disqualified. No fishing permitted in the point area after weigh-in begins. Fish will not be weighed if disqualification has occurred.*

## Tournament Rules (Cont.)

10. *5 bass per boat. Fish must be over 12" with only one over 18" per contestant. Scoring will be the weight system. The weight of undersize fish will be weighed and deducted from the weight of the remaining fish. The "Golden Rule" shall be the official measurement device. Winners of ties will be determined by those having the fewest fish.*
11. *Any contestant wishing to protest the action of a fellow contestant for bad sportsmanship or other infraction, must do so in writing to the tournament chairman after the weigh-in.*

1<sup>st</sup> place: 50%

2<sup>nd</sup> place: 30%

3<sup>rd</sup> place: 20%

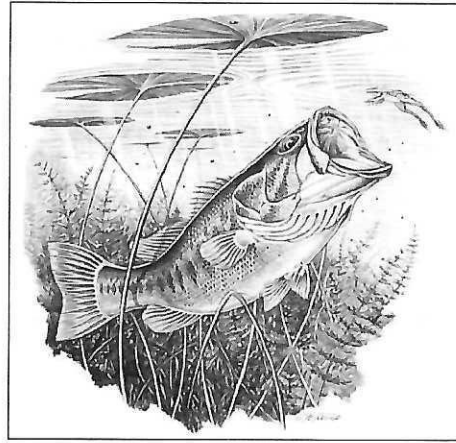

Mississippi

Named for prominent Mississippi jurist Joshua B. Clarke, Clarke County was established in 1833 out of Choctaw lands that were ceded by the tribe in the 1830 Treaty of Dancing Rabbit Creek and has a rich and interesting history that includes steamboat navigation on the Chickasawhay River, the advent of the railroad, and havoc wrack to the railroads and towns by Gen. William T. Sherman in 1864. Its agricultural base, especially cotton cultivation, a major lumber book that lasted into the 1930's, the growth of the textile industry, as well as oil and gas production, have contributed to the rich southern heritage of Clarke County. A number of lovely antebellum homes have survived and may be seen throughout the county.

Clarke County is 692 square miles of forests, farms, rolling hills, prairies, lakes, rivers, and streams located in east central Mississippi, inhabited by some 17,000 people. Quitman serves as the county seat, with 2,332 residents.

The towns of Enterprise, Shubuta, Stonewall, and the village of Pachuta make up the other non-rural areas. Rural areas which have 72% of the population, include many closely-knit communities, which contribute greatly to the overall quality of life of the county.

Clarke County meets the recreational needs of residents and visitors alike. Archusa Water Park provides natural beauty, nature trails, swimming, water skiing, fishing, boater camper and cabin facilities. Archusa Water Park, with its 440-acre lake, is situated within the city limits of Quitman.
